#### **Statement of Intent**

#### **Our Trust Vision**

To provide environments where children and young people can thrive.

Life in all its fullness - a place to thrive

#### **Our Trust Values**

Respect, Teamwork, Kindness

Our collective worship policy strengthens and supports the distinctiveness of each individual school, reaffirms the vision and associated values of each school and celebrates the central role that each child has to play in their community. The schools' vision and values are underpinned and supported by the Trust vision of "life in all its fullness" John 10:10. Our worship reflects the variety of traditions found in the Church of England, and will recognise and follow the Christian liturgical year. The daily act of collective worship is central to our ethos and is supported by all staff and governors. It makes an important contribution to the overall spiritual, moral, social and cultural development of the whole school community. In Church of England schools, collective worship is seen as more than a daily 'awe and wonder' moment. It is the unique heartbeat of the school and is offered as part of a wider opportunity for pupils and adults to encounter faith by engaging in conversations about God, both as individuals and together.

### 1. Legal Framework

- **1.1** This policy has due regard to all relevant **legislation** and **guidance** including, but not limited to, the following:
  - SIAMS Framework Church of England (September 2023)
  - Diocese of York Collective Worship guidance: 'Worship Works' (September 2022)
  - DfE (1994) 'Religious Education and Collective Worship'
  - DfE (2010) Religious education in English schools: Non-statutory guidance
  - DfE (2012) 'Religious education (RE) and collective worship in academies and free schools'
  - The School Standards and Framework Act 1998 (Section 70\*)
     \*This framework requires the Headteacher/Principal and Governing Body of every school/academy to provide a daily act of Collective Worship which is in line with the schools Trust Deed and foundation

#### • Right of Withdrawal

Parents/carers have the right to withdraw their child(ren) from acts of worship and this right is clearly stated on the school/academy website

# 2. Content and Structure of Collective Worship

- 2.1 'Collective worship' reflects an act which is special or separate from ordinary school-based activities. We understand that collective worship and assembly are distinct activities, and, although they may take place as part of the same gathering, the difference between the two will be considered.
- 2.2 Our worship is inclusive, inspirational and invitational. It reflects the variety of Anglican and Methodist traditions found in the Church of England and will recognise and follow the Christian liturgical year, with varied liturgical and other traditions of Anglican worship and festivals in the UK and worldwide and, where appropriate, the Eucharist. To appreciate the relevance of faith in today's world, by encountering the teachings of Jesus and the Bible and developing understanding of the Christian belief in the Trinitarian nature of God. It includes opportunities for prayer, reading and reflecting on the Bible, liturgy, sacrament and experience of the musical and other imaginative riches of Christianity.
- 2.3 Collective worship helps pupils and adults to reflect on our school's theologically underpinned Christian vision and values.
- 2.4 It offers the opportunity, without compulsion, for all pupils and adults to **grow spiritually** through experiences of prayer, stillness, worship and reflection.
- **2.5** It is an opportunity to **celebrate and give thanks** for achievements within the school, local and international community and occasions of significance, including festivals.
- 2.6 Our worship is planned and delivered by a number of different people including, staff, Trust chaplains and our pupil Collective Worship group and consists of 4 stages:
  - Gather we welcome the school community with music, liturgy and the lighting of a candle

- Engage we share, for example a Bible reading, followed by an activity to engage pupils with the Christian message
- Respond pupils have the opportunity for reflection through discussion, sharing thoughts, pray if they wish, sing
- Send we share the message of the worship again and ask the school community to reflect upon the message in their daily lives. We close with liturgy, final prayer, music and the blowing out of our special candle

## 3. Monitoring and Evaluation of Collective Worship

- **3.1** Monitoring and evaluation of collective acts of worship is undertaken by pupils, staff, and governors on a regular basis. All leaders of collective worship are asked to evaluate continuously, reflect after every worship, to develop and improve their practice
- 3.2 Collective Worship monitoring and evaluation is reported to the Trustees and school Governors through Distinctiveness and Personal Development (DPD) Committee and Local Governing Committee (LGC) meetings.
- **3.3** Worship is **independently inspected by law under Section 48 of the Education Act 2005** in consultation with the Diocese of York(SIAMS).

### 4. Monitoring and Review

- **4.1** This policy will be reviewed annually and approved by the Distinctiveness and Personal Development (DPD) committee.
- **4.2** All changes to this policy will be communicated to all Church schools and uploaded onto the respective school/academy websites.

#### **Our School's Vision**

### Growing together, serving others and living life to the full.

**Serving others** is a core part of Christian teaching. *Jesus said that he did not come to be served, but to serve (Matthew 20:28)*. That is still a radical claim that challenges our social order and is the model for our Christian lives. The Manor community seeks to serve others and does so in a variety of ways both inside and outside our school, to enable our staff, pupils, local and wider community to thrive and to flourish.

**Growing together** is a key part of a school, with students all developing and facing challenges together. 1 Corinthians 12 describes the church as a *'body with all parts being equally important'*. At Manor everyone is valued. We encourage students to be part of the school community which means supporting and encouraging each other.

Finally, *Jesus wanted us to live life to the full (John 10:10)*. The Christian faith does not set out restrictions on how we live our lives, but should set us free to be the people we were designed to be. Students have opportunities to experience all facets of life at Manor, through collective worship, extra-curricular activities, school trips and excellent teaching and curriculum.

#### **Our School's Values**

The Christian values we want to see developed in our young people are clearly shown throughout the bible, and are used by God to describe Himself in Exodus 34. We want each young person to be **gracious**, **compassionate**, **loyal**, **patient**, **kind**, **forgiving and just**. These values are displayed on banners in the school canteen, posters in classrooms and are in the students' planners.

Our cross on the school wall is a clear sign of our Christian foundation and serves as a reminder of what lies at the heart of the Christian faith.
